- 1.** I agree that I will be subject to a **\$50 per night** non-refundable cleaning fee for the additional service required to prepare my room for the next guest. Pet fee will not exceed \$150 for entire stay. **Per ADA regulations, there is no charge for service animals.**
- 2.** I agree to keep my dog on a leash or in a carrier while in public areas.
- 3.** I agree to keep my dog out of all food & beverage areas:
  - All dogs are allowed in the Piano Lounge; however, only service animals are allowed in the Spoonbread Restaurant and/or Joel's Java Coffee Shop.
- 4.** I agree that room cleanings/engineering calls must be scheduled in advance for a time when my dog and I will not be in the room.
- 5.** I agree to prevent noise or any other disturbance by my dog, in the interest of other hotel guests.
- 6.** I agree to pay any additional cleaning fees or repair bills, should they be required, and authorize the hotel to charge my credit card for such charges, even if they are discovered following my departure from the hotel.

## INDEMNIFICATION

I further agree that I shall assume full and complete responsibility for any personal injury or property damage caused by my dog; suffered by any guests, employees, or invitees of The Westin Poinsett Hotel, including the approved veterinarian and its employees. In the event that such personal injuries or property damage should arise, I agree to indemnify, defend and hold harmless The Westin Poinsett Hotel and/or Marriott Hotels, together with its past or present officers, directors, employees, agents, attorneys, insurers, affiliated companies, successors and assigns, for any claim which may arise.

## GENERAL RELEASE
