



Bring your pet(s) to our pet-friendly hotel and discover the city's finest with a companion by your side. The Four Points by Sheraton Jacksonville Beachfront warmly welcomes four-legged friends to our hotel. For the safety and comfort of our guests and staff, we ask that you follow these guidelines:

- Dogs weighing up to (40) forty pounds are welcome.
- Maximum of two (2) pets per guest room.
- Breeds that are prone to aggressive behavior are prohibited, unless for ADA purposes (includes chow chow, old English sheepdog, Rottweiler, giant schnauzer, pit bull, Staffordshire terrier, Doberman and miniature pinscher).
- Pets must be housebroken.
- Pets cannot be left unattended in your guest room or anywhere on the premises.
- Pets are not allowed in the public areas of the hotel such as the Great Room, Fitness Center, Breakfast Area, Lounge, Guest Laundry, Vending, Pool or food service areas.
- Proper medical certification specifying that all vaccinations are up to date must be available upon request.
- Pets must be on a controllable leash at all times when outside the guest suite.
- Pets must be walked in appropriate designated areas of the hotel and you are responsible for picking up after the pet in and around the hotel at all times. Ask the front desk for designated areas.
- Housekeeping Service - The pet must be removed from the guest room prior to housekeeping service or other arrangements must be made with hotel management.
- You are responsible for any and all damages including but not limited to: Scratches on doors or furniture and stains made by pet
- You are responsible for any injury inflicted upon any hotel employee or guest of the hotel.
- You agree to indemnify and hold harmless the hotel, its operators and owners and their respective affiliates from all liability and/or damage suffered as a result of their pet(s).
- Any compensation given to other guests due to excessive noise from your pet will be charged to your account.
- Anyone bringing in a pet without notifying the front desk will be charged a additional \$200 cleaning fee in additional to normal daily pet fee.
- The hotel reserves the right to remove guests whose pets are deemed noisy or disruptive.
- Credit card on file required.
