## **TERMS & CONDITIONS**

All facilities at the Resort are available for use by Pass Holders and their accompanied guests at their own risk, and they expressly assume all risks whether known or unknown. The Resort will not be responsible or liable, whether due to negligence or otherwise, for the loss or damage to any property of Pass Holders or guests or any bodily injury or death due to the acts or omissions of the Resort or its personnel or due to condition or operation of the Resort. The Resort has no duty to protect pass holders or guests or their property from damage or injury or to prevent theft or other criminal acts at the Resort. Pass Holders and guests hereby waive and release all claims against the Resort.

### **CONDITIONS OF RESORT PASS**

By my signature hereon, I hereby apply for Resort Pass at Sheraton Panama City Beach Golf & Spa Resort. It is understood that this Resort Pass is non-transferable and that if application is approved, such approval for Resort Pass grants no ownership or easement rights of any kind or character in the amenities, but does allow Pass Holder and accompanied guests (subject to availability) access to Resort amenities by reservation and payment of applicable fees during periods of time that amenities are made available for use, so long as a Pass Holder is in good standing. It is understood that Sheraton Panama City Beach Golf & Spa Resort's Officers and Directors reserve the sole right and discretion to delete, change or create new policies in relationship to amenity usage, amenity operations, rates, fees and assessments charged to utilize amenity properties without reason or notice.

It is understood that Sheraton Panama City Beach Golf & Spa Resort does not permit any Pass Holder to loan and/or grant permission to other individuals the usage of Pass Holder's card and/or Resort Pass privileges and that failure to adhere to this policy, as well as all other policies of the Resort, may lead to fines and/or suspension and/or cancellation of Resort Pass.

### **ACCOMPANIED GUEST POLICY**

Up to 4 accompanied guest of Pass Holder may enjoy Pass Holder discounts, provided the Pass Holder is paying for services on their Resort Pass. Unaccompanied Guest of Pass Holder will receive NO discount. All children (under the age of 18 years of age) must be accompanied by an adult at all times. Any children left unattended will be asked to join their parents. Non-compliance with this policy may result in the revocation of Resort Pass.

### **SERENITY SPA**

Day use of Serenity Spa facilities is subject to occupancy limits. Please call ahead to confirm availability. Age restrictions apply at Serenity Spa.

### **RESORT PASS PLAN AND CLUB RULES**

It is understood that I, my spouse and my approved dependents are responsible for reading and following the rules, policies and conditions as set forth. It is agreed that this Resort Pass and all persons approved for usage under this Resort Pass, by my signature hereunder, are bound by and shall comply with all the bylaws, rules, policies and regulations of the Resort as they may be amended from time to time, and as are posted at each venue. It is also understood that no reprimand shall be given to Resort associates by any Pass Holders. Complaints concerning normal operations of the Resort, and/ or Resort associates and/or other matters are to be made in writing, signed by the complainant, and directed to a member of the Resort Management team.

### **RESORT ACCESS METHODS**

Pass Holders may be given a key (or keys) to access otherwise restricted areas of the resort. It is the responsibility of the Pass Holder to control their key. Pass Holders must notify the resort promptly if a key is lost or stolen, so it can be disabled, and a new key issued. The Resort may charge a deposit for keys, may charge a fee for replacement keys that are lost or stolen. Keys may expire at the end of the pass term, and will need to be exchanged for a replacement.

**PAYMENT OF RESORT PASS ACCOUNT**

The Resort Pass is an annual commitment. Payments for the Annual Resort Pass are accepted on an annual or quarterly basis. Full annual payments receive an additional 5% discount and may be paid by check or credit card. Quarterly payments, for the annual Resort Pass, require a credit card on file with the Resort Accounting Department with permissions by Resort Pass Holder to automatically charge quarterly fees on the first day of purchase, January 1, April 1, July 1 and October 1. Resort Passes purchased within a quarterly cycle will be prorated to the next scheduled quarterly billing date. In the event a credit card on file declines a quarterly payment, the Pass Holder will have until the 10<sup>th</sup> of the month to provide an alternative credit card. If an alternate credit card is not provided, the account will become delinquent on the 11<sup>th</sup> day of the month that the payment was due and fees may be applicable. Delinquent accounts will be charged a delinquent fee equivalent to 1 (one) month dues, respective to the Resort Pass level, for each month in delinquency. Delinquent accounts will be suspended after the 30<sup>th</sup> of the first month and terminated after the 60<sup>th</sup> day of delinquency. Resort Pass privileges will not be available to Pass Holder while the account is suspension status. The Pass Holder will be responsible for the payment of the full delinquent quarter plus 2 months of delinquent fees.

The undersigned further agrees to pay all reasonable attorneys’ fees, investigation fees and other costs incurred in connection with the collection of delinquent accounts.

**CANCELLATION POLICY**

Cancellation of a Resort Pass (paid annually or quarterly) must be done by the pass holder in writing on or before 30 days preceding the first day of the desired quarter of cancellation. No refund of current quarter dues will be refunded. Notice of cancellation must be submitted in writing to the Sheraton PCB Resort, c/o Accounting Department at 4114 Jan Cooley Drive, Panama City Beach, FL 32408.

**RECALLABLE RESORT PASS**

Sheraton Panama City Beach Golf & Spa Resort’s Officers and Directors reserve the right to return deposits, if any, and to recall, with or without reason, any Resort Pass. Resort Passes may also be cancelled due to a change in ownership, foreclosure or bankruptcy proceedings, a sale, destruction, or seizure by eminent domain of the property. In the event of an unpreventable force majeure, cancellation of Resort Pass maybe considered if determined by the Resort that the services outlined in this agreement cannot be met. The Resort may also allow cancellation of the Resort Pass due to extenuating circumstance on the part of the Pass Holder as a direct result of said force majeure.

The undersigned hereby further acknowledges and authorizes the Sheraton Panama City Beach Golf & Spa Resort and Bay Point Golf Club to automatically charge any and all amounts owed on the quarterly payment schedule laid out in this agreement without any additional authorization, approval or signature of the undersigned.
