PET AGREEMENT

As a pet-friendly resort, we welcome you and your pet to Sheraton PCB Resort.

I hereby agree to the following regulations and conditions while staying at The Sheraton PCB Resort with my pet:

- Sheraton PCB Resort welcomes all well-behaved pets unless prohibited by state law. (Service animals are always welcome.)
- Guests must notify Sheraton PCB Resort when making reservations that they are bringing a pet, and guests must register pets in at check-in.
- I agree to a non-refundable \$150.00 cleaning fee upon check-in and a weight restriction of 45 Pounds per pet.
- I agree to keep my pet on a leash or in a carrier at all times while in public areas including on our beach, except when they are with their owners in their rooms.
- Your pet may join you (on leash) at Flip Flops Pool Bar, Beach, and Pelican's in the "pet designated" areas, but Health Department rules prohibit pets in or around the pools, hot tubs, or inside TIDES Restaurant & Lounge or Serenity Spa.
- I agree to be present while any member of the hotel staff, such as housekeeping or engineering, is in the room. Room cleaning must be scheduled in advance for a time when the pet is not in the room or the owner is present.
- In consideration of all Sheraton PCB Resort guests I agree to keep my pet with me or a designated individual at all times, and **NOT** leave him/her unattended in the room.
- I agree to pick up and discard my pet's waste in the appropriate container.
- I agree to prevent noise or any other disturbance by my pet, in the interest of other hotel guests.
- I agree that, should my animal create any disturbances, which cause complaints to be made to the hotel by other occupants or personnel of the hotel, at the request of the hotel manager, I shall immediately make arrangements to house my animal elsewhere outside the hotel.
- I agree to pay any additional cleaning bills or repairs should they be required and authorize the hotel to charge my credit card for such charges, even if they are discovered following my departure from the hotel.
